

MakeMyTrip South East Asia Trip Offer

Terms and Conditions:

1. This offer from MakeMyTrip (India) Pvt. Ltd. (MMT) is valid for HSBC Credit Card Holders ("Cardholder") only.
2. The cashback is valid for the bookings done from 1 April 2010 till 30 June 2010 ("offer period").
3. The Rs. 5,000 cashback is valid on South East Asian holiday package bookings for a couple .
4. The Cardholder has to book a holiday package and not just the hotel stay to be eligible for the cashback.
5. The offer is valid on offline bookings (only) and the Cardholder needs to quote the deal code "HSBCSUMMER" at the time of booking to be eligible for the cashback.
6. The holiday offers are not valid on Flight + Hotel online bookings.
7. The Cardholder will be required to make payment as per the price quoted by MMT on www.makemytrip.com (MMT website) or at telebooking centre, without considering the cashback benefit.
8. The cashback will be credited within 7 working days following the date of such bookings, and MMT will process a credit transaction for the cashback amount on to the Cardholder's card account. The cashback shall be credited to the same credit card as was used for the purpose of making the purchase and will be reflected in the monthly credit card statement.
9. The cashback would be calculated excluding the airfare from the holiday package and cashback will not be applicable on the air fares and the taxes. All taxes including but not limited to Airport taxes, Visa charges, high season surcharge are payable by the Cardholder and are not part of the cashback offer.
10. The cashback will be calculated on each booking ID and not on number of transactions. So if a Cardholder pays in 2 installments/transactions for 1 booking ID, the cashback will be calculated on basis of the base amount or card charged amount (whichever is lower) of the booking ID.
11. If the Cardholder doesn't receive cashback amount, he/she can claim for the same within 3 months from the booking date by calling MakeMyTrip on their contact centre numbers. In the event the Cardholder fails to do so, he/she will not be eligible for the cashback amount.
12. The Cardholder cannot club two offers during the same transaction. The cashback benefit cannot be combined with any other promotional benefit offered for bookings on MMT, except in scenarios where the other benefit is not extended/funded by MMT.
13. If the Cardholder cancels the travel service purchase after the cashback amount is credited, MMT will refund the purchase price after deducting the cashback amount and any other applicable cancellation charges / penalty. E.g. If a Cardholder has paid Rs.10,000 (price quoted by MMT) for a travel service and a cashback of Rs.1,000 has been credited to the Cardholders account, the net amount paid by the cardholder is Rs. 9,000. Thus, if the Cardholder cancels the booking, MMT will deduct the cancellation charge/penalty from Rs. 9,000 and the balance amount will be credited to the Cardholder's account.
14. Travel date change is allowed, however the Cardholder has to bear the additional charges as required.
15. Service charges as applicable shall be payable by the Cardholder.
16. Prior to using the MMT website, the Cardholder should read and understand the User Agreement of the said website and proceed to make purchases only if the Cardholder agrees to abide by the same. The Cardholder shall be required to give personal information and credit card details online for the tickets purchased on www.makemytrip.com. The Cardholder should read and understand the Privacy policy for the MMT website, prior to providing such information.
17. HSBC shall not be held liable for any personal details shared by the Cardholder on the MMT website.
18. Any disputes arising out of this offer shall be taken up directly by the Cardholder with MMT. The existence of any dispute shall not, by itself, constitute any claim against HSBC.
19. Disputes, if any, arising out of or in connection with or as a result of above offers or otherwise relating hereto shall be subject to the exclusive jurisdiction of the competent courts / tribunals in Mumbai only, irrespective of whether courts / tribunals in other areas have concurrent or similar jurisdiction.
20. Cardholders, who are Travel Agents by occupation, are barred from making bookings for their customers using their own HSBC credit cards. MMT reserves the right to cancel such bookings if such a case comes to the notice of MMT. For such cases, MMT will not refund the booking amount.
21. The Bank and MMT reserves the right, at any time, without prior notice and without assigning any reason whatsoever, to add / alter / modify / change or vary all of these terms and conditions or to replace, wholly or in part, this offer by another offer, whether similar to this offer or not, or to extend or withdraw it altogether.
22. By availing this offer the Cardholder shall be deemed to have accepted all these aforementioned Terms and Conditions in totality.
