- 1. As per the prevailing Banking Companies (Nomination) Rules, Nomination can be made only in favour of an individual and there cannot be more than one nominee on an account.
- 2. Nomination made by the account holder/s/Guardians can be modified any time.
- 3. Request for registration/variation/cancellation of nomination should be submitted in the prescribed form (in duplicate) duly signed by the account holder/s/ Guardians and should be submitted to any branch of the Bank in India.
- 4. If there is more than one account holder, then the Nomination Form should be signed by all account holder/s. A copy of the Nomination Form will be held in the Bank's records and the other copy will be dispatched to the account holder/s/ Guardian on the address notified in the Bank's records.
- 5. Any registration of nomination, cancellation or change in the nomination has to be duly witnessed.
- 6. In case a thumb impression is affixed by the account holder/s/Guardian on the Nomination Form, two witnesses are required, one of which has to be a bank official and the other an external person (known to the customer) as per the RBI guidelines.
- 7. Each fixed deposit is an individual account and therefore different nominations can be given on each account. Please mention a correct fixed deposit number against each nomination.
