- **The minimum order value to avail the offer is INR 499** after excluding Grofers cash, delivery charges, and surge charges
- The final payable amount after the applicable discount will be visible on the OTP page
- **The coupon code will not be applicable if a cart contains any baby food product**
- In case of a partial refund to be processed, the discount amount will be calculated on a pro-rata basis, with the proportionate discount amount being subtracted from the refund amount.
